MEDICAL RELEASE STATEMENT

1 _____ I, the undersigned do hereby consent to any x-ray, anesthetic, medical, surgical, or dental diagnosis or treatment that may be necessary for my child. Further, I understand that all efforts will be made to contact me prior to treatment. In the event I cannot be reached in an emergency, I give permission to the staff of Peace With Christ Christian School and Early Learning Center to make the decisions necessary for treatment. I further understand that the doctors, dentist, and other providers attending my child will take all reasonable safety precautions during their care. As parent or legal guardian I am responsible for the health care decisions for my child and agree that my insurance plan is the primary plan for dental, medical, or hospital care or treatment that is given my child. Any policy of the school or church will be used as secondary coverage.

RELEASE TO USE PHOTOGRAPHS OF STUDENTS AND CAMPUS FIELD TRIP WAIVER

2 _____ I give permission to Peace With Christ Christian School and Early Learning Center to use photographs taken of my child during school activities to promote and market PWCCS and ELC on internet websites, posters, televisions, yearbook, brochures, and other posted forms of display. I waive any right to inspect or approve the photographs and any right to royalties or other compensation. I agree to hold harmless the Board and staff of Peace With Christ Christian School and Early Learning Center from and against any claims, damages or liabilities related to the use of the photographs.

3 _____ I grant permission for my child to participate in Early Learning Center activities on the Peace With Christ Lutheran Church and School campus, including interior and exterior locations within the property lines of Peace With Christ Lutheran Church and School.

FINANCIAL POLICIES

4 _____ I recognize the ELC may not be open on all dates set forth in the ELC calendar for varying reasons, including, but not limited to weather and/or the inability to use the facilities. There will be no deduction in tuition for snow days, breaks, holidays, illnesses or absences. Beginning September 1, 2013, monthly auto draft payments may be arranged through the ELC office. Please see the enclosed auto draft agreement form for more information.

5 _____ I understand that the registration fee is charged annually.

6 _____ Part Day families only: I understand that tuition for preschool is due on the first school day of each month, and considered late after the 7th of the month. I understand that if payment is not made by the 15th, my child's discharge may be required.

7 _____ Full Day families only: I understand that full day tuition is billed monthly and due on the first day of each month, and considered late after the 7th of the month. Beginning August 1, 2013, auto draft payment arrangements **must** be made through the ELC office if bimonthly or weekly payment plans are desired. Monthly auto draft payments may also be arranged as desired. For more information, see enclosed auto draft agreement form. If payment is not received by the 15th, a late fee of \$15 may be assessed.

8 _____ I agree that enrollment as specified within this contract may be canceled by the parent or legal guardians without penalty (except forfeit of the registration fee, and tuition and other fees already collected) with 30 days written notice to the Director for part day classes and 2 weeks notice for full day. I will be responsible for those 30 days/2 weeks tuition, regardless of attendance. There will be no adjustment in yearly tuition for preschool after April 1st regardless of notice.

9 _____ I understand that the ELC closes at 6:00 p.m. for childcare and 11:30 a.m. or 2:45 p.m. for part-day classes. I agree to pay a late pick-up charge of \$1.00 per minute per child if my child is not picked up by his/her program's designated dismissal/closing time. ELC staff determines the official time using cellular phone time and/or the clock at the ELC sign-in desk.
